## The 411 Corner

 Last month, the 411 Corner reminded advisors of the SL-Requirement and how students may be eligible for a substitution class to satisfy that graduation requirement. Note that it is the purview of **Associate Dean of the College (ADOC) Mary Crawford** to both determine *if* the student is eligible for the substitution and *what* that substitution course will be. So, if you think your advisee meets the requirements, make sure they make an appointment with Dean Crawford.

## Faculty-ing: The Grade of Incomplete

An instructor might give the grade of Incomplete to a student when the student's work is of passing quality, but they are unable to complete the course for reasons beyond their control. Some reasons for an Incomplete may include serious illness, family emergency, personal injury, and an unexpected situation near the end of the course. The keys are that the student was doing well in the course before the event *and* that the student can complete the course requirements in a short time after the end of the course. There are no set definitions for “doing well” (although a C average through 75% of the class seems reasonable to me) or for “short time” (although a couple of weeks seems reasonable to me).

To be perfectly clear, you are *never* required to give a student an Incomplete. It is entirely up to you to allow it (although the ADOC must approve the application). If you do decide to allow the Incomplete, there is (of course) a form to fill out. The “**Application for Incomplete**” form can be found in the expected place on the Registrar’s website. Click on Faculty Tools then on Faculty Forms. The form is a bit more than half-way down the page in the “Student Electronic Forms” section.

The student should complete the form — which requires the signature of Associate Dean of the College (ADOC) Mary Crawford — and submit it to the Registrar’s Office. When it comes time for you to submit grades for the students, you should give the grade they would receive if they


do no more work in the class. When the student does the make-up work in the prescribed time, grade it, determine the student's grade, and email the Registrar with this change of grade.

Technically, it is the **Academic Standing Committee (ASC)** that approves the Incomplete (through the ADOC).

## The Book Corner

 In addition to the 411 Corner introduced last month, someone else suggested that I provide information about interesting/useful books that can be found in the **Seymour Library Faculty Development Collection**. This month, let me draw your attention to

Belcher, W. L. (2019). *Writing Your Journal Article in Twelve Weeks: A guide to academic publishing success* (2nd ed.). University of Chicago Press.

In this book (**Z471.B45 2019**), Belcher provides advice to beginning scholars in many disciplines. She builds on feedback from professors and graduate students who have successfully used the workbook in her first edition to complete their articles.

Remember that the library also has access to a lot of journal articles and newspapers. Here is an article about GenAI checkers. I think the most interesting thing about this article is its currency (October 18, 2024) and its discussion of two types of errors (false positive and false negative).

# Faculty Funding Opportunities

## Old External Funding (Repeat Announcement)

[\*The Mellon Emerging Faculty Leaders \(MEFL\)\*](#) are building inclusive campus communities through their teaching, scholarship, and service. Awardees are early-career faculty whose research focuses on contemporary American history, politics, culture, and society. In addition to bringing a diversity of perspectives to their fields, MEFL awardees are building support systems, networks, and affinity groups for their students and peers.

- Applicants eligible for the Mellon Emerging Faculty Leaders Award will be assistant professors in tenure-track appointments who are pursuing tenure.
- They will have successfully passed the standard third-year/midpoint review or their institution's equivalent no later than January 31, 2025.
- Eligible applicants are typically in the fourth or fifth year of the tenure-track appointment and are still working to complete key items for the tenure dossier, which should not be scheduled for submission prior to the end of the award year (Summer 2026).
- Please note that the award seeks to support progress toward tenure for scholars who are also meaningfully engaged in building campus community; therefore, applicants who are already effectively in a position to go up for tenure.
- Applicants must be U.S. citizens or permanent residents of the United States as of December 1, 2024 (please include a copy of your green card with your application supplemental items if a permanent resident).
